Another new thing to make the most of is the new IXION Trial Schools - before the next few trials we are to have a one hour school before the trial begins (from 9-30 until 10-30), so get an early start for the next trials and make a positive move to improve your skills.

COMING EVENTS.

Nov.14th.: IXION Club trial at Arcus property, Otaki (at Otaki Forks), kick-off at 10-30, but we will have the first pretrial School starting at 9-30, so stay sober on Sat.night this is an early start job .

Nov.16th.: The first of the 1988/89 Twilight Series trials. Start time 6-30 at Ash Wells' property, 112 Ohariu Rd., Johnsonville. If you can turn up any earlier & help lay out a section or two it would be appreciated, so too would helping clean up afterwards.

Nov.26th.: 1988 NZ Experts Trial, hosted by Manawatu Orion at Palmerston North. See enclosed entry form.

Nov.27th.: 1988 North Vs. South Trial, hosted by IXION - yes that's us folks, last year our club took this title almost on our own so we want to lay on a really good event. The Trial is being held at Perkins' property Paekakariki, which is a great property. There are 15 sections planned, so we will need lots of observers, so if you don't intend riding come along & observe (it would be appreciated if you could ring Ash or Mark in advance & let us know if you can help).

Dec.4th.: IXION Christmas Trial, to be held at Battle Hill on the Paekakariki Hill road. This is always good value - a simple fun trial followed by such semi controlled lunacy as motoball, eggthrowing, lolly scrambles for the "kids" etc. followed by a barbeque & beer. Don't miss it.

Dec.14th.: Twilight trial - venue not yet definite, possibly the reclaim at the Rail Ferry Terminal.

NUMBER PLATES - as per ACU rule book.

RIDING NUMBERS - Experts as per finishing place in 1988 N.Z champs, or as determined by National Trials Coordinator.

Intermediates and Clubmen as per 1989 North Island numbers listing, or as allocated by event organiser.

We intend running Intermediate and Clubmans grades separately to the N.Z Experts Trial with the intention of Experts observing for Intermediate and Clubmen (and hopefully giving some tuition at the same time) and vice versa. It's something new and different and we think it should work if all riders who enter are prepared to give it their support. Note: an early start is essential. Any Intermediate rider who wishes to also enter the Experts Trial may do so for an extra \$2 (no killer sections!).

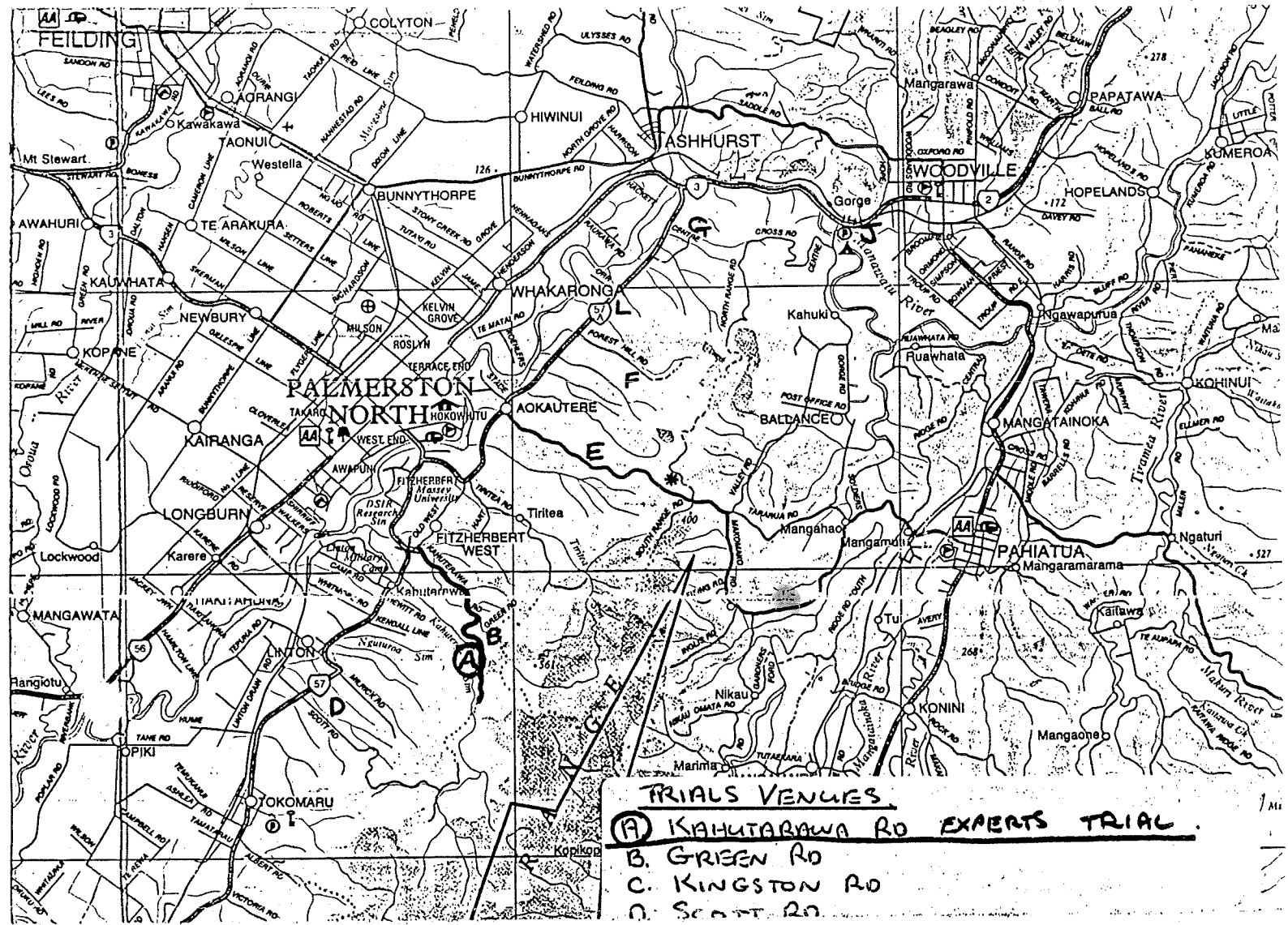
If there are less than 15 Expert entries we shall consider reverting back to the normal system, in which case all entrants who enter by the closing date will be notified of changes in start times etc.
